General Requirements: All funds disbursed are LOANS (maximum \$3,000 per semester), which become due and payable 90 days after graduation or termination of eligibility. Applicant must be a United States citizen, a legal Texas resident, under age 28, planning to enroll in an accredited institution of higher learning for the upcoming term with a minimum of 12 semester hours. A minimum GPA of 2.5 EACH SEMESTER will be required. School to be attended must be in the United States. Not all applicants will be approved, and those that pass the initial screening will be invited to Stanton for a personal interview with one of the Trustees. Successful applicants will be selected from among that group based primarily on financial need.

In order to be considered for funding, all required information must be received by July 1 for the Fall Semester or January 2 for the Spring Semester. No funds are available for Summer Semesters or for Graduate School. Which semester are you applying for: _____, 20____
